Notes:

1. Service providers have been assigned fixed appointments (up to a maximum of 3 per week), until 14:00, daily. Overtime submission of applications, in bundles of at least 10, is still valid.

2. Apointmens are scheduled for 30mins. During this time, as many applications as possible will be received (5-6 on average), depending on their complexity and correct completion.

3. At one service point daily, people without an appointment (walk-ins) will be served to submit 2-3 applications at a time. Providers with regular weekly appointments are excluded from this facility. They cannot be served any other day / time, except during their scheduled appointment. Overtime submission of applications, in bundles of at least 10, is still valid.

4. In case where there is time available at other service points, walk-in service will continue.

5. It is not allowed for taxi drivers or messengers to submit applications.
