

## Self-Declaration by the Applicant who has received services for the purposes of the Cyprus Investment Programme

This declaration must be completed and submitted by the Applicant who has received services for the purposes of the Cyprus Investment Programme (hereinafter referred to as the "Programme") by a service provider registered with the Registry of Service Providers of the Cyprus Investment Programme..

I declare responsibly that:

1. The service provider, on the basis of an agreement for the provision of services, has fully informed me of the Programme and has provided me with an accurate and satisfactory explanation of all the provisions of the Programme and of the best practices in regards to its implementation.
2. The service provider has notified and explained to me the Code of Conduct, with which he has confirmed to have complied, as well as with any other regulations concerning the Programme, including instructions and guidelines for the promotion of the Programme.
3. Conducting my investments as outlined in the Programme, I have fully adhered to the provisions and objectives of the Programme. I certify that I have not and do not intend to take any action that circumvents the provisions and objectives of the Programme. I understand that any circumvention of the provisions and / or objectives of the Programme may result in the loss of citizenship, expected to be granted under the Programme. I also understand that any circumvention of the provisions and / or objectives of the Programme is a deception of the government of the Republic of Cyprus, which constitutes a criminal offence.

4. I declare that my service provider has provided me, either himself/herself or through his/her key professional associates, complete information and advice in relation to the provisions and objectives of the Programme, the selection of investment and the selection of residential property.
5. I understand that the deposition of real estate contracts, the provision of bank guarantees in relation to performance bank guarantees, securing a bank waiver for property I am investing in, are some of the tools I can use to secure my interests. I certify that my service provider has fully explained all the relevant measures.
6. I have appointed the service provider to handle my application and to submit all the reports required under the provisions of the Programme.
7. If any indication of non-compliance of the Service Provider or its professional associates with the Code of Conduct and / or any other regulations regarding the Programme becomes evident to me, I will report it immediately and in writing to the Committee of Supervision and Control of Service Providers.
8. I declare that I will not take any action either personally or through the service provider I am working with, which has as a purpose to influence the work of the government departments involved in the examination of my application.
9. All the information provided in regards to my application to obtain a naturalization by exception, in relation to myself and my family, is true and complete.
10. I am aware that if any misconduct is detected in the process, or a violation of the above terms, the Government may either reject my application or deprive me from the citizenship, which is expected to be granted to me under the Programme. In such a case, the application for naturalization or the citizenship of the members of my family, as specified in the Programme, may also be affected.
